

Pressiton Finance Terms and Conditions

1. A website registered as www.pressitonfinance.com (further as Pressiton Finance) with all the contents placed on this website are the sole property of the company Pressiton Poland Sp. z o.o. based in Czestochowa, ul. Waly Dwernickiego 117/121. All contents placed on Pressiton Finance, including published offers, cannot be used, copied or circulated in any form without written consent from Pressiton Poland.
2. Portal Pressiton Finance serves to placing offers, concerning the sale of business (section Sell Business), offers concerning search of investor (section Seeking Investor) and it also serves to registration as an Investor (section Seeking Investment).
3. Pressiton Finance reserves the right to remove offers with content beyond the confines mentioned in point 2.
4. Pressiton Finance is not responsible for the contents of placed offers.
5. Pressiton Finance reserves the right to remove offers violating proper manners, Polish law, offending other users and also offers edited carelessly or repeating.
6. Filling in personal data in the registration forms of Pressiton Finance, the user agrees to the publishing of data on the website and on collecting, storing and processing of said data by Pressiton Finance.
7. Pressiton Finance, in offers on the website, does not publish e-mail addresses or telephone numbers of advertisers. People interested in contacting advertisers can, after entering details of the offer, send them a message using the form placed in the details. E-mails sent from the Pressiton Finance website will be delivered to the advertiser and also as information for Pressiton Finance.
8. A user placing an offer in the section Seeking Investor or Sell Business can, once logged-in to his/her account, fill in forms of balance sheets and profit and loss reports of his/her company or project (actual data or forecasts) with the purpose of generating a report containing over 40 financial ratios. This data will be accessible for people interested in the company or project after their registration through the form Seeking Investment and after gaining the access to look through these documents.
9. A user placing an offer in the section Seeking Investor or Sell Business can, once logged-in to his/her account, enclose additional documents concerning his/her company or project such as business plans, financial statements, contracts with suppliers, patents and others. This data will be accessible for people interested in the company or project after their registration through the form Seeking Investment and after gaining the access to look through these documents.

A user filling in forms defined in the point 8 or enclosing additional documents defined in the point 9 can give the access to look through them to any user registered in Pressiton Finance database as an Investor. Giving the access is only possible once logged-in to his/her account and using the option Define the rights.
11. Pressiton Finance can give the access to look through the documents placed on the website according to point 8 and 9 to any user registered as an Investor, if Pressiton Finance will find the user a potential buyer of a company or a potential investor.
12. Pressiton Finance reserves the right to remove offers of competitive portals.
13. Pressiton Finance reserves the opportunity to take part in transactions between advertisers and people interested in the offers.
14. Pressiton Poland reserves the right to execute mailing (sending advertisements) to the e-mail addresses of users registered on the Pressiton Finance portal.
